### 2.1 ACTION: Attendance Options for the Balance of the 2020/21 School Year

The Board should consider and take action to determine the manner of student attendance for the remainder of the 2020/21 school year. There are, essentially, three (3) student attendance options for the Board to consider:

- **Status Quo** - remain on minimum days for the balance of the year, continuing to serve our Distance Learners in the afternoon.
- **Full Day w/an Option for Distance Learning** - transition to full days prior to the end of the school year and continue to provide an option for Distance Learners in some manner.
- **Full Days w/o an Option for Distance Learning** - transition to full days prior to the end of the school year for all students, without a Distance Learning option.
