2. COMMUNICATIONS

2.1 Public Comment

Members of the public may address the Board on any items of interest to the public that are within the subject matter jurisdiction of the Board, but are not on the agenda. Each person who addresses the Board must first be recognized by the presiding officer and then give his/her name. Comments must be directed to the Board as a whole and not to individual members or District employees. Individual speakers will be allowed three (3) minutes to address the Board. However, the Board shall not act upon, respond to, or comment on the merits of any item presented during the Oral Communications, although the Board may ask clarifying questions of the presenter or refer the presenter to a District procedure if appropriate. 3. INFORMATION AND DISCUSSION

3.1 2020-21 School Reopening Plan

EXPLANATION: Board will discuss options for the reopening of schools for the 2020-2021 school year. El Dorado County is not currently on the COVID Monitoring List of counties, which means it is possible for the District to reopen with face-to-face instruction; however, El Dorado County is trending toward being placed on the Monitoring List at about the same time as school is scheduled to reopen. Additionally, there are significant concerns regarding the El Dorado County Office of Public Health's capacity for testing and contact tracing. This lack of capacity mirrors the experience at state and national levels; therefore, it is necessary that the Board consider these factors in deciding how to reopen schools for the 2020-2021 school year.
