BACKGROUND: School districts are required to submit for review and approval by the Board of Trustees the First Interim Report of the District for the period ending October 31, 2022. The purpose of the First Interim Report is to present an overview of the District's financial condition and review whether the District is able to meet its financial obligations in the current and subsequent two fiscal years. Although the District is projecting deficits in the current and subsequent years, the District maintains adequate reserves to positively certify this report. In addition, upon review and certification by the Board of Trustees, the First Interim Report will be reviewed by the El Dorado County Office of Education as part of its fiscal oversight of school district.
